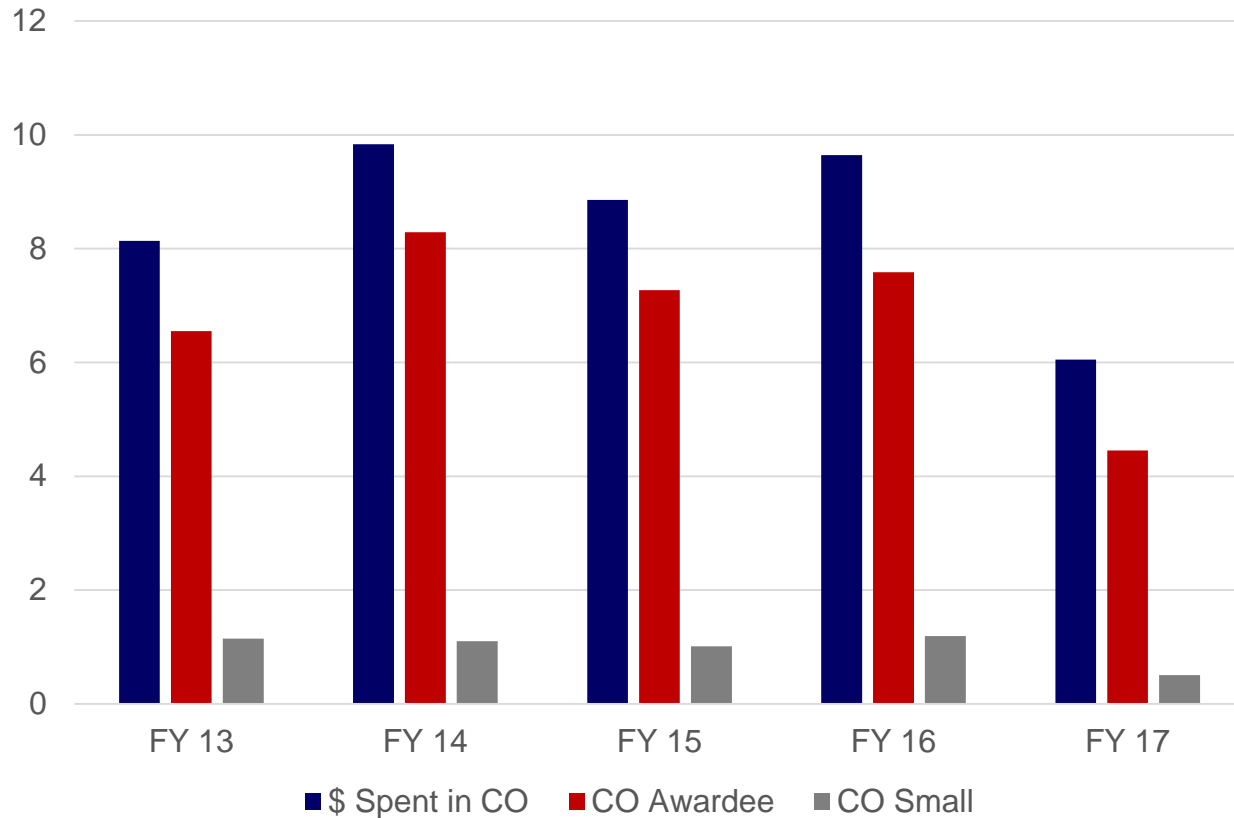

Fed Spending in CO (Billions)

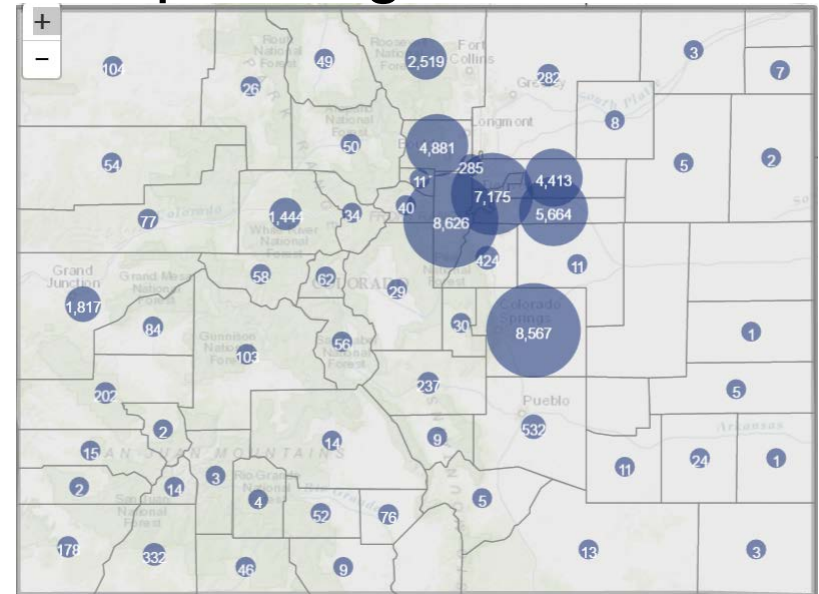
